विद्यापीठ सलग संलग्नीत / कायम संलग्नीत / स्वायत्त (Continuation / Permanent /Autonomous) असलेल्या सर्व महाविद्यालये / संस्था यांचे प्राचार्य / संचालक यांना विनिर्दीष्ट परिपत्रकानुसार सूचित करण्यात येते की, शैक्षणिक वर्ष २०२४-२५ साठीचे सलग संलग्नीकरणाचे / नैसर्गिक वाढीचे / कायम संलग्नीकरणाचे प्रस्ताव ऑनलाईन प्रणालीद्वारे सादर करणे आवश्यक आहे. सादर प्रस्ताव ऑनलाईन सादर करण्याकरिता खालील सूचनांचे पालन करावे.

- १) विद्यापीठाचे <https://muonline.org.in> या संकेत स्थळावर लॉगिन केल्यानंतर, संबंधित प्रस्तावांचे विभाग (Section) मध्ये (उदा. Activate Link of Continuation of affiliation Proposal-2024-25) लिंक देण्यात आलेल्या आहेत. या लिंक द्वारे महाविद्यालये आपल्याला आवश्यक त्या अर्जाच्या लिंक सुरु (Activate) करू शकतील.
- २) आवश्यक त्या अर्जाची लिंक प्राप्त झाल्यानंतर अर्जाच्या सुरुवातीला संलग्नीकरणासंबंधीत मागणी करित असलेल्या अभ्यासक्रम / तुकडी इत्यादींचा तपशील ऑनलाईन अपडेट करावा.
- ३) पूर्वीचे शैक्षणिक वर्ष २०२३-२४ करिताचे सलग संलग्नीकरणाचे (Continuation of Affiliation) प्रस्ताव महाविद्यालयाने ऑनलाईन विद्यापीठास पाठविले असतील अशा महाविद्यालयांची माहिती शैक्षणिक वर्ष २०२४-२५ करिताच्या प्रस्तावमध्ये दिसून येईल.
- ४) आवश्यकतेनुसार अभ्यासक्रम / विषय काळजी पूर्वक तपासून घ्यावे. महाविद्यालयास नको असणारे अभ्यासक्रम / विषय महाविद्यालय वगळू शकतात किंवा आवश्यक असल्यास नवीन अभ्यासक्रम / विषय नमूद करू शकतात.
- ५) आपण ऑनलाईन अर्जामध्ये नमूद केलेल्या अभ्यासक्रम / तुकड्यांनुसार आपल्याला संलग्नीकरण शुल्क भरणे करण्याकरिताची लिंक निर्धारित शुल्कासह उपलब्ध होईल. परंतु निर्धारित शुल्क भरणे करिताची सुविधा फक्त एकदाच उपलब्ध असेल, म्हणून निर्धारित शुल्क / अभ्यासक्रम / तुकड्या / विषय यांची खातरजमा प्राचार्यांनी / संचालकांनी केल्यानंतरच ऑनलाईन पद्धतीने संलग्नीकरण शुल्क भरावे. तदनंतरच सादर अर्ज / प्रस्ताव ऑनलाईन विद्यापीठास सादर झाला असे समजण्यात येईल.
- ६) ऑनलाईन प्रक्रिया पूर्ण केल्यानंतर अर्जाची एक प्रत (Hard Copy) महाविद्यालय संलग्नता व विकास विभागात ऑगस्ट महिन्याच्या अखेरच्या दिवशी (सायंकाळी ०५:०० वा. पर्यंत) सादर करण्यात यावी.
- ७) ऑनलाईन अर्ज सादर करण्याबाबतच्या विस्तृत सूचना <https://muonline.org.in> या संकेत स्थळावरील Proposal Guidelines for Current Academic Year या लिंक द्वारे उपलब्ध करण्यात आलेल्या आहेत.
- ८) उपरोक्त उल्लेखित ऑनलाईन पद्धतीने जे अर्ज प्राप्त होणार नाहीत. अशा अर्जासंबंधित महाविद्यालयामार्फत / संस्थेमार्फत करण्यात आलेल्या कोणत्याही पत्र व्यवहाराचा विचार विद्यापीठाकडून केला जाणार नाही, याची नोंद घ्यावी.

CIRCULAR

Attention of the Principals of all affiliated aided, partially aided and unaided (Minority and Non-Minority) colleges is invited to this Office Circular No.Aff./Recog./173, dated 13th June, 1991, No.Aff./ Recog./254, dated 5th July, 1993 and No.Aff./Recog./188 of 2008 dated 17th May, 2008, regarding 1) fees prescribed for application to be made for affiliation of new colleges and for continuation and/or extension of affiliation and/or permanent affiliation of the existing colleges and 2) receipt of late application and fees prescribed therefore and they are hereby informed that, the Management Council at its meeting held on 16th August 2007 vide item No.5, 15th September, 2011 vide item No.41 and 28th June, 2012 vide item No.13 has amended ordinance 158 which reads as under :-

O.158: All applications for opening of new colleges shall be sent (ten copies) or extension of affiliation shall be sent (in five copies) to the Registrar in the form prescribed by the Management Council so as to reach him before the last day of October of the year preceding the year from which affiliation is intended to take effect. All applications for continuation of affiliation or permanent affiliation of colleges shall be sent (in five copies) to the Registrar in the form prescribed by the Management Council so as to reach him on or before 31st August of the year preceding the year from which affiliation is intended to take effect.

Provided that in the case of colleges in respect of which the period of continuation of affiliation or extension of affiliation (Natural Growth) or permanent affiliation, recommended by the Senate expires before the date on which a copy of the University letter forwarding to the Government of proceedings of the Senate meeting was received by the college, the application for continuation of affiliation or extension of affiliation (Natural Growth) or permanent affiliation shall be sent (in five copies) to the Registrar in the form prescribe by the Management Council within two months from the date of the receipt of the said letter and in the case of colleges allowed to be started by the University on the basis of initial approval received from the Government in August or thereafter, shall be sent (ten copies) to the Registrar in the form prescribed by the Management Council within two months from the date of the receipt of the letter from the University permitting the Society /Trust to admit students.

Application for affiliations for opening of new colleges, continuation of affiliation and / or extension of affiliation and / or extension of affiliation (Natural Growth) or permanent affiliation of colleges shall be accompanied by fees as mentioned below:-

In case 31st August and/or before the last day of October of the year preceding the year happen/s to be a Sunday or Public Holiday, the last date for accepting applications for continuation of affiliation or extension of affiliation (Natural Growth) or permanent affiliation and opening of new colleges and applications for extension of affiliations shall be the immediate previous working day.

A copy of the application for opening of new college shall also be sent by registered post to the State Government directly.

Provided that the application for extension of affiliation (Natural Growth) or continuation of affiliation or permanent affiliation of college received after 31st August shall be accompanied by in addition to the fees mentioned above, a late fee of ₹5,000/- for colleges for professional courses and ₹1,000/- for colleges for each courses [i.e. Bachelor of Arts, Science & Commerce and Self-finance courses**] other than professional courses (including colleges of Education and Law) for each month subsequent to the month of August, as the case may be, including the month in which the application is received.

Provided that in the case of colleges in respect of which the applications for extension of affiliation (Natural Growth) or continuation or permanent affiliation of colleges received after two months after a copy of the University letter forwarding to the Government the proceedings of the Senate meeting was received by the college and application for continuation of affiliation of colleges received after the receipt of the letter from the University permitting the Society/Trust to admit students on the basis of the initial approval received from the Government, shall be accompanied by the addition to the fees mentioned above a late fee of ₹5,000/- for colleges for professional courses and ₹1000/- for college for each courses [i.e. Bachelor of Arts, Science & Commerce and Self-finance courses**] other than professional courses (including colleges of Education and Law) for each month subsequent to the second month, as the case may be, including the month in which the application is received.

The Management Council reserves to itself the right to reduce/waive late fee as prescribed hereinabove, in receipt of application for extension of affiliation (Natural Growth) or continuation of affiliation or permanent affiliation of colleges and opening of new Colleges or extension of affiliation in exceptional circumstances. The Management Council reserves to itself the right to refuse to consider any application received after 31st August and/or before the last day of October of the year preceding the year, as the case may be.

One-third of the amount of affiliation application fee received with a application for opening of new college shall be refunded to the Society/Trust whose application for opening of a new college is not recommended by the University and is not approved by the State Government or whose application is recommended by the University to the State Government but is not approved by the State Government.

Where a college having applied for permanent affiliation is granted continuation of affiliation one-half of the amounts of permanent affiliation application fee received with the application shall be refunded.

Affiliation application fees including late fee, if any, shall be paid by means of a demand draft payable to the Finance and Accounts Officer, University of Mumbai and drawn on any scheduled bank in Mumbai. However, the colleges in Greater Bombay may pay affiliation application fee including late fee if any, by means of a crossed account payee Cheque on a Scheduled Bank/State Co-operative Bank in Mumbai.

*Professional courses mean courses in Medicine, Dentistry, Pharmacy, Architecture, Ayurved, Homeopathy, Unani Medicine, Management Studies, Engineering, Education Medical Laboratory, Technology, Prosthetics & Orthopedics, Audiology & Speech Therapy, Occupational Therapy, Physical Therapy, Law, Labour studies, Labour laws & Labour Welfare, Taxation Law, Dance, Music, Applied Art, Painting and include such other courses as may be decided to the professional courses by the Management Council from time to time.

****[Self-finance Courses :- 1) B.Sc. (Hospitality Studies), (2) B.Sc. (Microbiology), (3) B.Sc. (Bio-Chemistry), (4) B.Sc.
