## CIRCULAR

Attention of the Principals of all the affiliated colleges is invited to this office circular No.Aff./Recog./177 dated 13<sup>th</sup> June, 1991 and Aff./Recog./26, dated 20<sup>th</sup> January, 1995, regarding payment of yearly affiliation and late fees prescribed in O.158- A and they are hereby informed that the Management Council at its meeting held on 16<sup>th</sup> August, 2007 vide item No.5 amended the said Ordinance to read as under:—

O.158-A: Every affiliated college shall pay to the University yearly affiliation fee, on or before 31st January of each year, on the basis of the strength of students on the roll of the college on 31st December, of the preceding year as under:—

Colleges for Professional \*Courses –

- (i) Colleges for Professional courses excluding colleges of Education, Find Arts and other professional courses not required to register with All India Statutory Bodies..... Rs. 30,000/-
- (ii) Colleges of Education, Fine Arts and other Professional courses not required to register with All India Statutory Bodies but with students strength more than 300 students for degree courses..... Rs. 30,000/-
- (iii) Colleges of Education, Fine Arts and other Professional colleges not required to register with All India Statutory Bodies but with students strength less than 300 students for degree courses.... Rs. 20,000/-
- 2. Colleges for courses other than Professional courses :-
  - (i) Having strength of students upto and inclusive of 500.... Rs. 2,000/-
  - (ii) Having strength of students upto and inclusive of 501 to 1000 .....

    Rs. 4,000/-
  - (iii) Having strength of students between 1001 and 1500..... Rs. 6,000/-
  - (iv) Having strength of students above 1500..... Rs. 8,000/-

The number of students admitted in the Junior College attached to the degree college shall be excluded in arriving at the strength of students for the above purpose. Every affiliated college shall remit yearly affiliation fee as prescribed above to the Finance & Accounts Officer, University of Mumbai, together with penalty, if any

A Penalty at the rate of Rs. 200/- for a sum of Rs. 2000/- per month or part thereof shall be paid to the Registrar, University of Mumbai, by the affiliated college, if the annual affiliation fee is not paid on or before the last day of February.

All fees including penalty, if any, shall be paid by means of a demand draft payable to the Finance & Accounts Officer, University of Mumbai and drawn on any Scheduled Bank in Mumbai. However, the Colleges in Greater Mumbai may pay annual affiliation fee including penalty, if any, by means of a crossed account payee cheque on a scheduled bank/State Co-operative Bank in Mumbai.

\*Professional courses means courses in Medicine. Dentistry, Pharmacy, Architecture, Ayurved, Homoeopathy, Unani Medicine, Management Studies, Engineering, Education, Medical Laboratory, Technology, Prosthetics & Orthotics, Audiology & Speech Therapy, Occupational Therapty, Physical Therapy, Law, Labour Studies, Labour Laws & Labour Welfare, Taxatlon Law, Dance, Music, Applied Art, Painting and include such other courses as may be decided to be the professional courses by the Management Council from time to time.

The above amended Ordinance 158-A has been brought into force with effect from the academic year, 2008-09.
